- CAC Logo Kellie Kaukani reported the logo should be ready for approval, soon.

4. SELPA Reports:

- Superintendents have received the Annual Determination Notices from the California Department of Education. The purpose of the Annual Determination Notice is to communicate to the LEA the compliance monitoring activities that the LEA will be required to participate in during the current year. The SELPA Leadership team is preparing to support our LEAs in these activities, specifically the Performance Indicator Review. Additionally, we are collaborating with Riverside County Office of Education to support those LEAs that have been identified as eligible for differentiated assistance based on the LEAs California Dashboard data for Students with Disabilities
- Riverside County SELPA, in partnership with El Dorado County SELPA (N. Cal) and West San Gabriel Valley SELPA (Greater LA Area), has been named the Statewide SELPA System Lead for the State of California. The role of the SELPA System Lead partners will be to work directly with the California Department of Education and the California Collaborative for Educational Excellence to empower SELPAs and LEAs to improve outcomes for students with disabilities. The SELPA System Leads will be working specifically to build capacity among SELPAs and County Offices to bring common language to all aspects of education, break down silos, and move toward "ONE SYSTEM". Our driving values at this time are that all students are general education students first, that each student deserves a special education, and that focus on data and continuous improvement are critical to improve outcomes.
- We have a new Governor ... Governor Newsom released his proposed budget this week and there are a few highlights specific to special education. The proposed budget includes \$576 million to special education, \$1.86 million of one time funds, to support expanded special education services and school readiness supports at local educational agencies with high percentages of both students with disabilities and unduplicated students who are low-income, youth in foster care, and English language learners. The focus of the new administration includes: 1) Coordination between general education and special education programs, 2) transparency around local planning for regional special education services, and 3) transitions between regional centers and local educational agencies for three-year-old children with exceptional needs
- SELPA Team Updates Amil Alzubaidi, ERMHS Coordinator, was recently named Director of Special Education for Perris Union High School District. RC SELPA will be recruiting to fill the position of ERMHS Coordinator.
