Discussion and Information Items

11. Compliance Monitoring Updates

- PIR -plans are currently being worked on. PIR Drafts are due to SELPA by May 24th. SELPA has asked all Special Education Directors to involve cabinet members and begin to prepare each governing board.
- Disproportionality and Significant Disproportionality- CDE is requiring a new approach for Directors. The process is becoming more time intensive. SELPA has received inquiries of LEAs noncompliance. If noncompliance continues, there will be fiscal sanctions. SELPA is identifying ways to add value. SELPA will send calendar invites to comply with timelines.
- SEIS-Synergy model request. Synergy model is a checks and balances for compliance monitoring. We will reach out to SEIS regarding compliance monitoring. RC SELPA carries the contract for SEIS. There may be time to review what other options are out there.

12. SELPA Systems Improvement Lead Updates

SELPA along with CLS are working on a data integration toolkit. There is continuous improvement training scheduled throughout the state. SIL are in the process of high level practices around UDL improvement work. A series of UDL workshops including students with disabilities will be held November 21, 2019 at Beaumont Unified School District.

The CAC Recognition Event was successful. Over 200 people participated in the event. Lake Elsinore USD won the surfboard competition. Dr. Lyon and Scott Baily were both nominated for recognition awards.

RC SELPAs new Executive Board was announced and we are looking forward to a great year.

16. Non-Public School Updates

There has been conversation around starting a new NPS. Oak Grove is very interested in opening a Desert site; they are looking at options for facilities. They need a commitment of 6 kids clustered in each grade level.

17. Coalition for Adequate Funding for Special Education and State SELPA Highlights

a. Legislative Updates

Jeff Vaca spoke during the Superintendents meeting on AB 428. It was passed out of assembly appropriations; it would provide equalization for all SELPAs. This would be an Increase of \$64,958 in RC SELPA. SSC should send out notification in the next couple of days.

State SELPA is monitoring SB 217-Portonino Bill (early childhood funding bill) closely.

b. Fiscal Updates

The Governor's May revise increases \$200 million to education. The budget went from a one-time funding to ongoing funding. AB 428 language still lends itself as a concentration model. As soon as Leah receives those numbers, she will push out to Superintendent's.
