## 7. Nonpublic School Updates

#### a. Master Contract Rates

Master contracts are done. Rates are up with a low number of NPS's available. Lunches were an issue, NPS' have been instructed to include the price of lunch in the daily rate. Daily rates are typically between 150.00-175.00 per day.

### b. CDE Oversight and Compliance Monitoring

Bright Futures, Childhelp and Altus are all on Conditional Status. BERs are not going to Districts.

#### C. SELPA-wide NPS Needs

CDE indicated NPS' landscape will change. Some ideas discussed were NPS co-op, SELPA and RCOE creating an NPS either together or separately. Suggested that a subgroup be put together with Superintendents, Directors and Fiscal. Facilities are a real issue; it was suggested that a charter school could

possibly be an option. Doug asked Finance Committee Liaison to come up with the fiscal impacts. RCOE has a skeleton of a plan to bring forward.
