Discussion and Information Items

- 6. Community Advisory Committee Updates
 - a. Distribution of Information

SELPA had a conversation with the CAC Executive Board, regarding the distribution of information and flyers. SELPA has emailed information to SpEd Directors and Secretaries, but information is not getting to most parents. Peachjar and Parent square are being used by LEAs for fliers. Parents have to opt in to such applications. SELPA will send flyers to LEAs to distribute and the district will disseminate.

b. Upcoming Events

Wednesday, October 17, 2018 - Emergency Preparedness, full day workshop. The trainer is retired police officer who has also trained Temecula School District. SELPA is working with the Red Cross to see if they will send someone out.

7. Nonpublic School Updates

a. LEA vs. NPS Responsibilities - Hermosa Beach City School District Case

If there is a concern or dispute, the ALJ will hold the district responsible. Hermosa Beach City case; NPS staff was restraining the student without notifying the district or parent. This case is a reminder to have oversight of NPS'. SELPA no longer contracts directly with Terri, Inc.

b. Master Contract Approval Process

RC SELPA is involved in a due process matter, often times SELPA has been dismissed from cases. SELPA does the master contracts. Some contracts may come forward to Governance Council for ratification. Information to come.

c. Update on Non-Public School Alternative Work

The NPS landscape will be changing. Darrin, Stacy and Leah met a few weeks ago to discuss NPS alternatives. Now have a good skeleton on paper. RCOE has a proposal drafted. What does the ideal NPS look like? How is there more benefit to our students? It's moving forward.

8. Compliance Monitoring Activities

a. Disproportionality

All but one of our LEAs have submitted their student review data. Now we look forward to our APR data.

b. Data Management and Analysis - The Changing Landscape

On behalf of SpEd Directors-bring your CALPADS and CASEMIS people together. Will align in 2019-20. SELPA has found from different groups that the two groups are not communicating. CLS has agreed to come out and do data sessions. SELPA will require that LEA send teams; a decision maker, CASEMIS person and a CALPADS person. John from CLS knows our data, we have asked for 4-5 sessions. Corey met this week with CASEMIS technicians.

9. SEIS Access - Regionalized Programs

Coordinating Council learned that County Office Administrators (Itinerants) didn't have access in SEIS to see students that receive services. LEAs only have read access to county students. SpEd Administrators need full SEIS access to enter the Offer of FAPE. Many directors would like to give limited access to their team members. Thoughts?? It was recommended that SEIS have a position based access-representing county. Would like to explore. It's important to have controls over who has access. Does SEIS have the capability to track changes in SEIS (like google).

10. Differentiated Assistance

a. Instructional Leadership Network (ILN)

Last month SELPA co-presented with RCOE, it was well received. Building that bridge to move to one system. Will be co-presenting again in January.

b. Request for Application - SELPA Systems Lead

SELPA Systems Lead has been released. Governor set aside 10 million dollars to support Differentiated Assistance. 6 million dollars will be divided -system lead partnership. 4 million dollars will be for content lead. Have to apply as a partnership. Each SELPA must submit their own application with SELPAS that they would like to partner with listed. RC SELPA has been sought out by a number of partners and have identified our partnership with West San Gabriel and El

Dorado SELPA. Partnership confirmation was made late Tuesday night. Conference call scheduled today at 2pm with both SELPAs to outline where we are headed and highlighting work with John Elyer. Framework will be driven by data.

11. RC SELPA Website Updates

October 19th is the release date for SELPAs new website. Met with web designer this week to discuss final changes.
