INFORMATION ITEMS

2. Community Advisory Committee Updates

CAC Updates were provided. LEAs are encouraged to continue recruiting CAC representatives. RC SELPA currently has a number of vacant CAC representative positions as well as a vacant position on the CAC Executive Committee (Member at Large). Upcoming events include the Fall Business Meeting on November 15, 2017 that will include a presentation by JoAnne Lauer of RCOE regarding the California Dashboard and Students with Disabilities. A full day workshop will be held on November 28, 2017 at Hemet USD regarding "The Parent's Role in Supporting Inclusive Practices".

3. Accountability Data and Compliance Monitoring Activities

a. Disproportionality Review

All LEAs have submitted the required data for the student file review. Results from the Disproportionality Student File Review and Policies and Procedures Review are pending CDE analysis.

b. Performance Indicator Review (PIR)

All LEAs have submitted the required Assurances form. LEAs are beginning to host stakeholders meetings in preparation for the development of the PIR plan. PIR plan is due to CDE by January 31, 2018.

c. Data Identified Non-compliance (DINC)

Thirteen LEAs were identified for DINC based on the June CASEMIS submission. DINC corrections and compliance plans are due to CDE by November 30, 2017 via the secure portal.

d. Comprehensive Review (CR)

One LEA has been identified by CDE for a Comprehensive Review. RC SELPA will support the LEA through this process.

4. 2017-18 Professional Learning and Development Update

Already this school year RC SELPA has facilitate professional development for more than 750 participants. Topics have included special education leadership, legal topics, educational related mental health services, supporting English language learners, compliance monitoring, special education finance, and early childhood.

5. Nonpublic School Update

CDE has completed a review of Big Springs and Oak Grove. RC SELPA is currently waiting for the review reports.

6. Dyslexia Guidance Update

CDE will be providing updates to the California Dyslexia Guidance that was provided in August 2017. It is anticipated that updates will be statutory in nature. Special Education Directors participated in a round table discussion at October Coordinating Council to share what each individual LEA was doing to address Dyslexia.
